Financial Review:

President's Report:

President Hartnett introduced Angie Schiltz as the new Milton Township Mental Health Board Manager. Angie introduced herself and the board welcomed her to the team.

Funding Partner Presentations:

Four funding partners provided updates on their programs at the 6-month mark.

DuPage Pads – 50 Milton Township residents from 36 households have been provided with case management services in the permanent supportive housing program.

Little Friends – Milton funding supports 24/7 care for four boys with intellectual disabilities who reside in a group home.

World Relief – Resettlement has ceased. With Milton funding, 28 Milton Township residents have received case management and counseling.

Easter Seals – Milton funding enabled Easter Seals to hire two part-time social workers to support their pediatric mental health program.

President Hartnett requested a motion to adjourn. Member Brosnan motioned. Member McCarthy Seconded. All were in favor. The meeting was adjourned at 7:00 p.m.


